Marlboro County hereby requests that you re-review the information submitted to the State Office of Victim's Assistance. Your letter states on page 23 that Marlboro County will be responsible for reimbursing the Victim Assistance Fund \$11,986.96. However, Marlboro County provided documentation that \$36,446.64 was transferred to the Victim's Assistance Account from the General Fund during this time period.

Therefore, there should be no reason for Marlboro County to owe any additional funds to the Victim's Assistance Fund.

Please be advised of the following:

- 1) The Victim's Assistance job description has been revised per your recommendation.

- 3) Administration will request a copy of the monthly deposit reports from the relevant County offices and will review for accuracy.
- 4) The County transferred \$36,466.64 from the General Fund to the Victim's Assistance Fund during the period audited. Therefore with \$11,986.96 deducted, the county transferred a surplus of \$24,459.68 to the Victim's Assistance Fund.

- 5) The County will not transfer any funds donated to outside entities.
